The difference is due to the fact that "a person" can be counted more than once in different months, but "only once" in the general total at the bottom of table.

(*) According to the related regulation, paid checks which have a value over 1.000.000.000 TL are decided to be included into the statistics from February 2015. Therefore, "Amount" of paid checks was revised according to this regulation.
